

## **About Chimney Rock PPD**

The Chimney Rock Public Power District service territory covers approximately 1,200 square miles in the central panhandle of Nebraska. The CRPPD service territory encompasses portions of Morrill, Scottsbluff, Banner, Box Butte, and Sioux Counties. The CRPPD territory is divided by the North Platte River with roughly three-fourths of the service area north of the river. There are two significant reservoirs, Lake Alice, and Lake Minatare in the northwestern portion of the CRPPD service territory. The Chimney Rock National Historic Site is situated in the southcentral part of the service area. Chimney Rock currently has 12 employees, and approximately 3,000 meters.

#### The Ideal Candidate

Successful GM/CEO candidates will have a background working in a public power district, municipal utility, or electric cooperative with a **strong focus on understanding of financial issues, power supply, regional issues, and the importance of a safety culture**. If you are an analytical leader with strong industry knowledge, the ability to lead change and manage risk, possess a high level of interpersonal communication skills and you understand the importance of collaborating with others, these attributes will set you apart from other candidates.
