### **Job Opening**

Polk County RPPD is currently accepting applications for a Journeyman or Apprentice power line worker to join our team. The selected applicant will assist in the construction, operation and maintenance of PCRPPDs distribution and transmission system. This person will be enthusiastic about providing safe reliable electrical service, and will be committed to the highest level of customer satisfaction in accordance with NREA safety standards, applicable regulations, and PCRPPD established policies and procedures.

### **Job Description**

This position assists line crews in powerline construction; such as loading and unloading poles, pole framing, setting & tamping, guying, conductor stringing, sagging & tying in, etc. powerline maintenance; such as line patrolling, insulator & arrestor replacement, line hardware repair & tightening, transformer and meter installations, and right of way clearing and powerline maintenance; such as spraying, cutting & grinding brush and trees along, around and adjacent to powerlines and substations.

### **Job Requirements**

This position requires that the successful applicant have a High School diploma or equivalent and have successfully completed an accredited power line program or have equivalent experience. They must hold a valid driver's license with a satisfactory driving record, and possess or have the ability to obtain a Class 'A' CDL. The successful applicant will live within 20 minutes of PCRPPDs headquarters and must be available for on call rotations and emergency call outs whenever conditions require. They must be capable of communicating in English, both verbally and written and will be capable of completing correspondence courses and on the job training with the goal to advance to journeyman lineman. Successful applicant will be required to submit to a pre-employment background check, physical examination and drug/alcohol screening.
